Dogwood Pet Lodge shall exercise reasonable care for the pet brought by the owner to our facility. If interactive daycare or group play is requested for this pet, it is done so at the owners' request, and he/she recognizes and accepts all potential risks involved in such activities. It is expressly agreed by the owner and pet care provider that Dogwood Pet Lodge's liability shall in no event be responsible for any and all acts or behaviors or any event that is not in control of said pet while it is in the care of the pet care provider. The owner further agrees to be solely responsible for all acts and behaviors, including payment of costs for injury to staff, other animals, or damage to the facility caused by the pet
All charges incurred by Owner shall be payable upon pick up of pet. Dogwood Pet Lodge shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Dogwood Pet Lodge. The Owner agrees that in the event the charges area not paid when due, in accordance with this contract, Dogwood Pet Lodge will exercise their legal rights within ten days via written notice to the owner by certified mail. Dogwood Pet Lodge may dispose of a pet for any and all unpaid charges, at private public sale, at their sole discretion. In the event that this may happen, the Owner waves all statutory or legal rights to the contrary. If such sale does occur, and the sale price is not adequate to cover the cost of pet care and other charges, the owner shall than be liable to Dogwood Pet Lodge for the remainder of monies owed. If a pet in the care of Dogwood Pet Lodge should become ill or injured, or the state of the animals health otherwise requires professional attention, Dogwood Pet Lodge, at its sole discretion, may engage the services of a veterinarian or give other required attention to the animal. In this event, all expenses incurred will be the sole responsibility of the owner, and will be paid in full by sam OWNERS INITIALS
Owner specifically represents to Dogwood Pet Lodge that, to the owners knowledge, the pet has not been exposed to any contagious diseases within a thirty day period prior to check in. During the period of this agreement, owner also agrees to notify Dogwood Pet Lodge of any known exposure of pet to a communicable disease and hold pet out of attending Dogwood Pet Lodge until pet is symptom free for a minimum of 14 days or with written veterinary clearance. Owner further agrees to maintain current vaccinations are required by Dogwood Pet Lodge's policy. OWNERS INITIALS
DOGWOOD PET LODGE WILL NOT BE RESPONSIBLE AND WILL NOT PAY FOR ANY DOG THAT MAY GET CANIN COUGH, A REPIRATORY PROBLEM THAT IS FOUND COMMONLY IN AN AREA WHERE PETS ARE GATHERING. THE OWNER IS RESPONSIBLE FOR UNDERSTANDING AND KNOWING THE RISKS INVOLVED WITH BOARDING THEIR PET. DOGWOOD PET LODGE ENCOURAGES YOU TO TAKE THE TIME TO TALK WITH YOUR VETERINARIAN TO BETTER UNDERSTAND THESE RISKS. BY INITIALING BELOW, I UNDERSTAND THE RISKS AND COSTS ASSOCIATED WITH CANINE COUGH.
Dogwood Pet Lodge will not be responsible and will not replace any personal items that you leave with your pet. These items include leashes, collars, toys, tags, bedding etc. If any of these items are important to you, please do not leave them behind.
